## **Award**

### **Award Panel**

The selection panel will consist of members of the NCJAA Awards Committee assigned by the Awards Committee Chairman with a minimum of four members.

#### Criteria

This award is intended to recognize a jail administrator who has demonstrated initiative and imagination in the performance of his/her duty or for a specific meritorious service which significantly enhanced the overall operations of the detention facility or Sheriff's Office. Long years of service are a consideration, but not a determining factor. Those actions the jail administrator took to promote the detention profession and detention staff by establishing outstanding training programs, best practices and sound managerial skills will be given a high priority.

# **Qualifications**

A candidate must be a full-time jail administrator, a member in good standing, and a member of the NCJAA for at least one year. The nominating sheriff must sign the application.
