### Access to County Jails - Disability Rights North Carolina

Some sheriffs have received letters from Disability Rights North Carolina (DRNC) in which DRNC is requesting access to the sheriff's jail to conduct monitoring visits in the jail. At the time of the Association's March 6, 2023 email regarding this issue, the Association had requested DRNC's official designation as North Carolina's "Protection and Advocacy system" (P&A), however DRNC had not yet provided that documentation. Since that time, DRNC has produced the official designation documenting that DRNC is North Carolina's P&A through an appointment by former Governor Michael F. Easley in 2007.

Federal regulations [42 USCS § 10805] provide that a P&A [i.e. DRNC] has the authority to access facilities (including county jails) providing care or treatment of individuals with mental illness.

Sheriffs who have specific questions about a DRNC request to access your jail should consult with your office's own legal counsel for guidance.

#### **P&A** Access to Jails

Federal regulation allows for the creation of P&A systems and gives the P&A access to certain areas in jail facilities and other facilities (such as hospitals and nursing homes). 42 USC § 15043 and 42 USC § 10805 provide that a P&A system will "have access at reasonable times to any individual with a <u>developmental disability</u> in a location in which services, supports, and other assistance are provided to such an individual . . ." and to "have access to facilities in the State providing care or treatment" to individuals with mental illness.

P&A systems are also required to have "reasonable unaccompanied access to facilities including <u>all area</u> [sic] which are used by residents, are accessible to residents, and to programs and their residents at reasonable times." This would include, at a minimum, access during "normal working hours and visiting hours." 42 CFR § 51.42.

<u>Note</u>: "P&A activities shall be conducted so as to minimize interference with facility programs, respect residents' privacy interests, and honor a resident's request to terminate an interview."

#### Are Local Jails Considered "Facilities" Under the Federal Regulation?

Yes. The federal law and regulations governing P&A systems <u>includes local jails and State prisons</u> in the definition of "Facility." 42 USC § 10802; 42 CFR § 51.2.

#### **Do Jails Provide Care and Treatment to Inmates with Mental Illness?**

Yes. "Care or treatment" is defined under federal regulation to include "services provided to prevent, identify, reduce or stabilize mental illness or emotional impairment such as mental health screening... [and] medication supervision..." 42 CFR § 51.2. An "individual with a mental illness" is defined to include an individual with a significant mental illness or emotional impairment "[w]ho is involuntarily confined in a detention facility, jail or prison."

#### If a Sheriff Allows a P&A to Conduct a Monitoring Visit, When Must it Occur?

As noted above, at reasonable times. This would be determined by the sheriff and could mean during normal working hours or when the sheriff would normally allow visitation at the jail. 42 CFR § 51.42.

#### What Areas of the Jail Would be Subject to a Monitoring Visit?

Only areas used by inmates with mental illness or developmental disability, or areas where this type of inmate has access, including access to areas where the inmate attends programs.

<u>Final Note</u>: Because of safety and security concerns associated with civilian entry into a jail facility, which may include "<u>unaccompanied access</u>," a sheriff or the sheriff's legal counsel may wish to meet with DRNC prior to allowing entry of DRNC personnel into the jail. The goal of this meeting could be to reach an agreement as to exactly how the jail visit will be conducted to ensure the safety and security of DRNC personnel, the sheriff's personnel and the inmate population.
