### New 2024 Basic Law Enforcement Training (BLET) Course

The lesson plans and related materials for the newly revised Basic Law Enforcement Training course (BLET) are in their final stages of preparation and review. They will be completed later this spring in time for a pilot course to be offered beginning in July at Fayetteville Technical Community College.

Improvements and adjustments to the course based on this first delivery will be incorporated into the materials and it will be delivered again at 15 different schools beginning in January, 2024.

Improvements identified during these 15 deliveries of the course will be incorporated into the final 2024 BLET course and it will be delivered statewide at all schools beginning in July, 2024.

### Ishee Confirmed as NC Adult Correction Secretary

The North Carolina Senate has confirmed Gov. Roy Cooper's choice to lead the state's new standalone Cabinet-level agency overseeing adult prisons, probation and other community supervision.

Senators voted unanimously for Todd Ishee to remain secretary of the Department of Adult Correction. Cooper announced Ishee's appointment in September, before the department became an official agency on Jan. 1.

Ishee had been state prison commissioner within the Department of Public Safety since 2019, leading state prison operations during the COVID-19 pandemic. He had been recruited in August to lead the American Correctional Association, but Cooper persuaded him to stay and take the secretary's role.

During a judiciary committee confirmation hearing last week, Ishee discussed goals to lower the department's job vacancy rate, improve correctional officer safety and bolster offender rehabilitation efforts.

# Sheriff: Jail Expansion is Needed

Haywood County's new sheriff has been on the job for just for just two months, and is already chipping away at the 10-point plan that was the hallmark of his campaign.

Sheriff Bill Wilke, who was the guest speaker at a recent breakfast gathering of the Haywood County Chamber of Commerce, went through the 10-point plan, providing a status update on each point.

One of the goals that's front and center is a county jail that would more than double the jails capacity — from 109 to 264 beds at a cost of \$21 million.

"We need the jail," he told the group of business leaders. "Jails save lives. There are more people hurt by the drug epidemic outside of jail."

Jail is an "uncomfortable place and it should be," he said, but there are programs in place to help those inclined to turn their lives around. Currently, about 80% of those incarcerated are serious offenders with a high bond.

He wrote that an added benefit to the expansion is that Haywood County could house inmates from elsewhere. The jails of many nearby counties are also at full capacity, and Haywood would be paid to house their overflow inmates, in turn offsetting the jail's price tag.

"Assisting our neighbors by offering this space contributes to a safer region altogether, and is reimbursed," Wilke wrote.

That far more advantageous than the current scenario where Haywood County is paying to house its inmates elsewhere.

"As you may know, our office has previously had to search for and pay for space to place Haywood County detainees during periods of full capacity, costing additional taxpayer expense in employee travel time and vehicle wear and tear to locations, at times, up to several hours away," he wrote. "We could limit these expenses and contribute to a safer Western North Carolina with this expansion."

His letter further stated that after a review of current plans and potential alternatives, he is satisfied that the current proposal offers the safest and most efficient means to protect both detainees and employees.

#### 10-point plan

Wilke began tackling the elements in his 10-point plan, which was a hallmark of his campaign, before he even took office in December. One of the priorities is forming an all-volunteer community advisory panel to make recommendations regarding addiction.

"To provide better mental health, we need to define it," he said, adding that solving the addiction problem will go a long way to reducing law enforcement issues.

A companion priority is to add a drug interdiction unit to better shut down drug traffickers between the Knoxville and Atlanta corridor, though that's not likely to happen soon because of funding, he said.

Two of the points on the plan are already in good shape, he said, referencing the pay and benefits plan for law enforcement officers and a countywide emergency response team.

Several other points are in the administrative pipeline — developing professionally tailored training for each job position within the department, collecting and analyzing data on the pre-trial release program that once operated in the county and working with the N.C. Highway Patrol to help make highways safer.

Other priorities on the drawing board include an effort to prevent victimization by staying connected to the community and recruiting volunteers to participate in the reserve officer program. Wilke said many have moved to or retired in Haywood County who have previous law enforcement experience and could help expand the department's volunteer reserve program.

### Onslow County Sheriff Office Introducing Body Cameras

One Sheriff Office here in the East is finally getting fitted with new gear, after waiting over a year.

In 2022, the Department of Justice committed nearly 230 thousand dollars in grant money to the Onslow County Sheriff's Office for new body cameras from Watch Guard Technologies.

The Sheriff's Department received them in December and started deploying them on the 12th of January.

The Sheriff's Office will be upfitting 83 vehicles and receiving 93 cameras in total. There will be enough for each deputy to have their own camera.

Deputies are also able to upload and download body cam footage from their cameras in their squad cars.

The department hosted an informational meeting where they broke down the plan for phasing in the new technology.

Sheriff Chris Thomas, Onslow County Sheriff Office said, "We're deploying them in stages. The first stage is Patrol, then the Driving while Impaired, then Warrant Squad, then the SROs in schools, and then the Civil Process Unit. As they're deployed each group that they're deployed to the deputies will be trained on that camera at that point."

The cameras will help address concerns with the public, exonerate the deputy, and provide more concrete evidence in court.

# 'Game-Changer': Durham County Sheriff's Office to Outfit Detention Officers With Body-Worn Cameras

The Durham County Sheriff's Office is receiving more than \$260,000 to add to its camera fleet and bring body-worn cameras into the detention facility for the first time.

In recent years, body and dash camera video has been at the center of some of the highest-profile crimes across many North Carolina agencies.

Durham County Sheriff Clarence Birkhead said the cameras have created more accountability across the board.

"I think it really was a game-changer for law enforcement just like the cell phone, you know. [It] really modernized communication and also gave the public another tool to capture law-enforcement interactions," Birkhead said. "Law enforcement as a profession is being able to use body-worn cameras in the same manner."

One year ago, the Durham County Sheriff's Office received nearly \$760,000 from the county to put 138 body cameras on every deputy during their shift and mount dash cameras in cars.

"Having this digital documentation, should someone file a complaint, we can pull the tape," Birkhead said.

This year, the department will bring in 114 additional body cameras and 26 more vehicle cameras.

Soon, every detention officer will wear a camera while working — a first for the department.

"Now having detention officers with a camera on them will again capture that interaction, it's just one more layer of us being able to document the interaction," Birkhead said.
